Information sheet for activities in accordance with the Hygiene Ordinance



Information for hairdressers/barber shops, foot care, podiatry, tattoo, piercing, cosmetics,

Legal basis

Anyone who carries out activities involving humans in which pathogens can be transmitted is subject to the State Ordinance on the Prevention of Communicable Diseases (HygieneVO) and infection hygiene monitoring by the health authority in accordance with the Act on the Prevention and Control of Infectious Diseases in Humans (Infection Protection Act IISG Section 38 Paragraph 2).

Duties

Anyone performing activities in accordance with the Hygiene Ordinance is obligated to comply with generally accepted and activity-specific hygiene rules. Knowledge of these rules must be acquired through appropriate training.

Anyone performing procedures that involve injury to the skin must disinfect their hands and the skin surface to be treated with a disinfectant immediately beforehand.

Disposable gloves and, if necessary, additional protective clothing must be worn during the activity.

The surfaces of the work area must be designed so that they are easy to clean and disinfect.

All internal infection control procedures must be documented in writing in a hygiene plan.

Only disinfectants from the VAH list or the RKI list may be used.

The reprocessing of equipment, tools, and objects intended to cause skin injuries must be carried out and documented after each use. The procedure should be selected appropriately based on the risk assessment.

To avoid injuries, sharp or fragile devices and objects must only be disposed of in puncture-, tear- and break-resistant containers.

The operator is obliged to draw up a hygiene plan and a cleaning and disinfection plan.

Last but not least, failure to comply with the hygiene regulations may result in administrative offence proceedings.

Properly prepared work materials/equipment must be available for each customer. Where possible, disposable materials should be used.

To determine the required number of work materials/equipment that should be available, the time required for the correct preparation of the work materials/equipment after each use must be taken into account.

Routine disinfection of work materials must be carried out.

Routine means:

- at least every working day
- always after contact with a customer with suspected skin infection
- always after visible contamination, e.g. with blood

The employees responsible for carrying out the processing must be instructed and regularly trained in accordance with the hygiene plan.

Surfaces must be cleaned after each customer and at the end of work and, if necessary disinfect.

Routine wipe disinfection of the following surfaces must be carried out:

- customer-facing areas
- spaces for storing equipment (including drawers)

Routine means:

- at least every working day
- always after contact with a customer with suspected skin infection

The persons responsible for implementing the above-mentioned infection control measures, the internal procedures including the disinfectants used must be recorded in writing in the hygiene plan.

For the selection of suitable disinfectants, the lists of the VAH and RKI mentioned in the HygieneVO must be used to ensure effectiveness, especially in relation to the required areas of action, such as fungicidal or limited virucidal

Towels and customer capes must be washed separately from cleaning cloths and mop covers at a minimum of 60 degrees Celsius. Towels, customer capes and cleaning utensils must be treated after each use. If possible, machine drying should be carried out after the wash cycle instead of air drying.
